- B. When the Vessel is not conducting any services for the Charterers, or is engaged in any extended sea passages, the Owners shall have the right to reduce the manning on board to an appropriate level. In such events, the Vessel shall return to its contractual manning level in advance of its requirement to re-commence services for the Charterers.
- C. In the event that the Charterers reasonably request any increase in the agreed manning level of the Vessel, all time and costs associated with such increase shall be for the account of the Charterers. Any increase in the number of crew carried on board shall be reflected by a corresponding reduction in the number of passenger beds available to the Charterers.

D. When the Vessel is chartered and operates as a dynamic positioned vessel, the following qualifications, issued by an approved body, shall be held by nominated members of the Vessel's Crew:

If the Charterers during the Charter Period should require the Vessel's Crew to have any additional training, qualification or certification in addition to what has been agreed in Clause D, then the Owners shall provide the Charterers with the time required, and the estimated costs to comply with the Charterers' additional requirements. Upon the Charterers' written acceptance of the time required and estimated costs the Owners shall, at the earliest opportunity, comply with the Charterers' additional training, qualification or certification requirements. The Owners' documented and specified costs incurred in complying with the Charterers' additional requirements shall be provided to the Charterers and shall all be for the Charterers' account.
